



# Large Diameter Condenser Microphone

# Description

The C400S is a large diameter, single pattern, condenser microphone. High sensitivity and low distortion make this microphone an ideal candidate for recording, broadcast, sound reinforcement, and vocal applications. The capsule in the C400S features a I inch gold vapor deposited diaphragm.

#### Hi-Pass

The C400S has an internal, switchable hi-pass filter to reduce pickup of low frequencies. To access the switch, first remove the swivel mount by unscrewing the knurled ring. Then unscrew the lower body adaptor and slide the housing off. The hi-pass switch is located on the printed circuit card. Push the switch in to enable the hi-pass filter.

#### Power

The C400S requires standard 48 Volt phantom power.

#### Power Indicator

The LED indicator on the front of the microphone lights when 48 Volt phantom power is applied.

#### Swivel Mount


The C400S comes with a swivel mount that will fit any standard 5/8" x 27 threaded microphone stand. The swivel mount can be removed by unscrewing the knurled ring on the bottom of the microphone.
